On behalf of Hon'ble High Court, Jharkhand, Ranchi Jharkhand Agency for Promotion of Information Technology (JAP IT), invites tender in form of sealed Techno-Commercial Bids for supply, installation and commissioning of HD Video-Conferencing set with local recording facility for inter-Jail Video-conferencing system to establish 7 no. of e-Court at 3 locations in which one unit will be at Ranchi and two unit each at Bokaro, Jamshedpur and Dhanbad.

The envelope containing the Technical Bid and the Bid Security will be opened on the specified date & time in the presence of Bidders or their authorized representatives who choose to attend. In the event of the date specified for bid receipt and opening being declared as a holiday for the office, the due date for submission and opening of bids will be the following working day at the appointed times.
