## Notice Inviting Tender

## "Invitation of bids for grant of "Composite License" (Prospecting Licensecum-Mining Lease)

In exercise of the powers conferred by Section [10B / 11] of the Mines and Minerals (Development and Regulation) Act, 1957 and in accordance with the Mineral (Auction) Rules, 2015 notified thereunder, the Government of Jharkhand has identified mineral block for the purpose of grant of Composite License for the Gold & Associated Minerals in Pahardia, West Singhbhum, District – Jharkhand, through electronic auction and hereby invites bids in digital format only from eligible bidders.
