The Chief Engineer, JSRRDA on behalf of Governor of Jharkhand invites the item rate bids in electronic tendering system for construction of roads under Pradhan Mantri Gram Sadak Yojana under Xth phase in the district of Khunti-10 Pkg, Cost Rs. 12.10 Cr.) for total 10 number of packages with estimated cost totaling to 12.10 Crore including their maintenance for five years from the eligible contractors registered in appropriate classes with RCD/ RDD/ R.W.D. Jharkhand, Ranchi/ CPWD/ MES/ in any other State Governments/ Central Government.\*

J.S.R.R.D.A. 3rd Floor, F.F.P. Building, H.E.C. Campus, Dhurwa, Ranchi, upto 02.01.17 till 17.00 hours, either by registered post or by hand, failing which the bids will be declared non-responsive.
