Drinking Water and Sanitation Department, Jharkhand intends to supply drinking water mainly from Ganga and any other perennial river/ water body in the vicinity of the Sahebganj, Dumka, Deoghar, Godda, Pakur, Giridih, Koderma & Jamtara district etc. through grid system of pipeline or canals as done in Gujrat from Narmada Dam. Expression of interest is invited from the reputed and experienced firms having team of competent professional, having sound financial position and having experience of doing such job successfully.
