TENDER FOR HIRING OF HELICOPTER ON CHARTER LEASE

The Govt. of Jharkhand invites tender under 2 BID SYSTEM for the following type of Helicopter on Charter Lease for assured Flight time of 25 Hrs per month:

Helicopter (Type Twin Engine VIP Conversion)

1. Seating capacity should not be less than 2+5 for VIP configuration in club type seating. The Helicopter must be equipped with latest avionics system, IFR, Weather Radar, Air-conditioned, ILS, transponders, Autopilot and GPS with type rated IFR Pilots.
2. The offer helicopter have demonstrable range to fly from Ranchi to any point in state of Jharkhand and return back to Ranchi without refueling with 5 passengers, full fuel and minimum 30min. of fuel as reserve.
3. Offered company should have experience of flying VVIP/VIP and should comply with safety norms as issued by DGCA Govt. of India and should be capable of providing it as a backup during major maintenance without any additional cost.
4. The Service provider may be manufacturer of Helicopter or NSOP holder company for at least five years.
5. The tender document must have two separate sealed envelopes mentioned as “**TECHNICAL BID**” and “**FINANCIAL BID**”. Both sealed envelopes must be sealed in another envelopes along with an earnest money in form of refundable bank guarantee of Rs. 10.00 Lakh in favour of the **Civil Aviation Department, Govt. of Jharkhand**, Payable at Ranchi.
6. **Technical BID** must have the following documents :-
 - a. The company should have at least three qualified pilots to fly VVIP/VIP as PIC on regular role of the company and should meet the DGCA, Govt. of India requirements to fly VVIP/VIP.
 - b. Current C of A, C of R and Insurance with other valid documents.
 - c. Proof that company has own valid NSOP and offered Helicopter should be endorsed on its NSOP.
 - d. Certificate of incorporation issued by Registrar of Companies.
 - e. Proof of seat insurance and third party liability.
7. **Financial BID** must be clearly spelt out in following :-
 - a. Fixed Monthly Charges (FMC) per month for assured 25hrs.- (In INR)
 - b. Additional cost per flying hours (when Exceeding flying time of 25 hrs.) - (In INR)

The fixed monthly charges shall include :-

Charges of hiring of Helicopter including all operational, Maintenance & administrative cost, including fuel transportation, crew accommodation and all airports charges including handling.

(No other extra charges will be payable by Govt. of Jharkhand during charter lease period)

8. The interested manufacturers/authorized representative, (possessing the necessary qualifications) may submit the technical bid and financial bid in sealed envelopes in the office of the **Civil Aviation Department, State Hangar, Near Birsa Munda Airport, Hinoo, Ranchi(Jharkhand) Telefax - 0651-2250287 upto 05.02.2015**.
9. The Technical bid documents shall be opened at 06.02.2015 on 13:00hrs. in the office of the **Civil Aviation Department, State Hangar, Near Birsa Munda Airport, Hinoo, Ranchi (Jharkhand)**. Desirous bidders may remain present at the time of opening the tender either in persons or through their authorized representative.
Financial bids of only those bidders would be open on 09.02.2015 at 12:00hrs. who fulfill the technical requirements mentioned above.
10. The successful bidder will have to sign an agreement with State Govt., Department of Civil Aviation, whose validity period will shall be One (01) year extendable with agreed escalation and with mutual consent.
11. Civil Aviation Department, Govt. of Jharkhand reserve the right to cancel or modify any of the above conditions or cancel any or all tenders without assigning any reasons.
