Inviting tender for supply of Parasail, Para Glider, Hang Glider, Powered Hang Glider (PHG), Powered Para Chute (PPC), Paramotor (Tandem),

Paramotor (Solo) and Paramotor (Back Pack)

Sealed tenders are invited from reputed manufacturer/ authorized dealers for supply of Parasail, Para Glider, Hang Glider, Powered Hang Glider (PHG), Powered Para Chute (PPC), Paramotor (Tandem), Paramotor (Solo) and Paramotor (Back Pack) to Civil Aviation, Govt. of Jharkhand as per following terms & conditions:-

- 1. The bidder should have an experience in supply of similar items either on temporary or permanent basis for at least 3 years.
- 2. The selected bidder at this own cost has to obtain DGCA registration (When applicable) of these items in the name of CAD, Govt. of Jharkhand.
- 3. The bidder should submit written consent for providing training to pilots and engineers and obtain all necessary endorsement and approvals for them. The all such cost shall be borne by the selected bidder.
- 4. All the costs, charges including stamp duty & registration charges etc. shall be borne by the selected bidder.
- 5. All Sanctions, Permissions, No Objections, License, Clearance and Approvals etc. shall be obtained by the selected bidder at his own cost.
- 6. The supplied items must comply with regulatory requirements of the state of manufacture and also current applicable requirements of DGCA. It is sole responsibility of the bidder to ensure compliance with all applicable regulatory requirements of DGCA. The bidder should submit declaration in above regards.
- 7. A penalty as decided by CAD, Govt. of Jharkhand for failure to comply with above requirement shall be levied to the successful bidder.
- 8. The tender document must have two separate sealed envelope mentioned as **Technical Bid** and **Financial Bid** respectively. Both sealed envelopes must be sealed in another envelope along with an earnest money in form of refundable guarantee of Rs. 5.00 lakh in favour of Civil Aviation Department, Govt. of Jharkhand payable at Ranchi.

Sealed offers for supply of above items should reach the office of **The Additional Chief** Secretary, Civil Aviation Department, Govt. of Jharkhand, State Hangar, Birsa Munda Airport, Hinoo, Ranchi latest by 05:00 P.M. on 25.03.2015 complete with technical and financial details.
