Bidding is open to all bidders from eligible source countries as defined in the bidding document.

J.S.R.R.D.A. 3rd Floor, F.F.P. Building, H.E.C. Campus, Dhurwa, Ranchi, upto 24.08.15 till 16.00 hours, either by registered post or by hand, failing which the bids will be declared non-responsive.
