**CATTLE BREED IMPROVEMENT PROGRAM**

**(Prototype Batch V, Under SCA to TSP)**

The Welfare Department, Govt. of Jharkhand has decided that there is need to improve the genetic build of local milch cattle belonging to S.T. Farmers in Jharkhand, and accordingly Project for the same under **(SCA to TSP) Prototype Batch V** has been sanctioned wide **letter no. 375 dated 08-02-2012** for the year 2011-12 in Mahuadanr block of Latehar district.

To achieve the objectives of the scheme, I.T.D.A Office Latehar invites “expression of interest” from the interested agency/ Non Govt. organizations under following conditions:-

- 1.1 The organization should be a non-profit-making, non-government organization duly registered in Jharkhand State since last ten years and the applicant Non- Govt. Organizations or any of their officer bearers who have been black listed by the Govt. of Jharkhand and any other Govt. shall not be considered eligible for application, under this scheme, the intending applicants must file affidavit in this regard.
- 1.2 The organization must be having the demonstrated experience of at least five year in the above field, and having minimum annual turnover of **Rs. 5 Crores.**
- 1.3 The intending applicant’s should file ITR clearance certificate for the last three years and must have the annual accounts audited properly.
- 1.4 The organization must be having the expert manpower technical know-how and required material/ service infrastructure to undertake such project.
- 1.5 The organization will have to provide all the dairy management consultancy service to the farmers at their doorstep backed up by related subject matter specialists.

**2. Application procedure :**

- 2.1 The intended organization fulfilling the above criterion may apply in prescribed “EOI” documents, which can be had from the office of Project Director, I.T.D.A , Latehar on payment of Rs. **5000/- (Rs. Five thousand only)** through demand draft drawn in favour of “Project Director, I.T.D.A, Latehar ” payable at Latehar.
- 2.2 The last date of sale of “EOI” documents is **27-08-2015 by 2:00 P.M.**
- 2.3 EOI document will contain “technical bid” documents and “financial bid” documents. Financial bid documents of only technically qualified organizations will be considered and opened, who qualify on the basis of “technical bid” documents submitted by them and as per norms/ parameters enclosed with the EOI documents. This programme will be for 5 years period and accordingly “Financial Bid” are invited incorporating the cost involved for this purpose.
- 2.4 The EOI documents will have to be submitted by **31-08-2015 by 11:00 A.M.** along with the earnest money of Rs **1,00,000.00 (Rs. One Lac.)** in form of bank draft drawn in favour of “Project Director, I.T.D.A, Latehar ” payable at “Latehar” in sealed envelope super scribing “EOI”-“**cattle breed improvement program**”, which will contain two separate sealed envelopes, one containing and super scribed as “**financial bid**” and the other as “**technical bid**”. The “**Financial bid**” of the suitable applicants shall be **opened on 31-08-2015 at 3:00 P.M.** in the presence of the applicants before the Committee formed for the purpose by the undersigned.
- 2.5 Incomplete EOI documents, other than in prescribed form without proper enclosures/ documents or earnest money or requisite fees as such will not be perused or considered under any circumstances.
- 2.6 Request for submission of bid documents after due date and time will not be considered under any circumstances.
- 2.7 The applicants whose “EOI” does not qualify for final selection, the earnest money drawn in favour of Project Director, ITDA, Latehar shall be returned forthwith.
- 2.8 The applicant whose “EOI” qualifies for selection finally, the earnest money drawn by the PIA’s shall remain deposited as security in the Office of P.D. ITDA, Latehar and shall be liable to be released only after successful completion of the Project. In case of any lapses/ non compliance of the direction issued by the

welfare department Govt. of Jharkhand and those issued by the office of the under signed, the earnest money deposited shall stand forfeited.
