## Re-e-Procurement Notice (PR No. 119838)

The Government of India has received a loan/credit number "Ln 7995-IN/Cr.4848-IN/Cr.4848-IN" from the International Bank for Reconstruction and Development/International Development Association towards the cost of Rural Roads Project (Pradhan Mantri Gram Sadak Yojana) and intends to apply a part of the funds to cover eligible payments under the contracts for construction of works as detailed in the Invitation for Bids. Bidding is open to all bidders from eligible source countries as defined in the bidding document.

The Chief Engineer, JSRRDA on behalf of Governor of Jharkhand invites the item rate bids in electronic tendering system for construction of roads under Pradhan Mantri Gram Sadak Yojana under XIth phase in the district of Godda-07 Pkg, Cost Rs. 15.96 Cr. and Dhanbad-01 Pkg, Cost Rs. 2.04 Cr. for total 16 number of packages with estimated cost totaling to 18.00 Crore including their maintenance for five years from the eligible contractors registered in appropriate classes with RCD/ RDD/ R.W.D. Jharkhand, Ranchi/ CPWD/ MES/ in any other State Governments/Central Government .\*

Availability of Bid Documents and mode of submission: The bid document will be available online from 18.12.2015 and should be submitted online in <a href="www.pmgsytendersjhr.gov.in">www.pmgsytendersjhr.gov.in</a>. The bidder would be required to register in the web-site which is free of cost. For submission of the bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities. The bidders are required to submit (a) original demand draft towards the cost of bid document and (b) original bid security in approved form and (c) original affidavit regarding correctness of information furnished with bid document as per provisions of Clause 4.4 B (ii) of ITB with C.E. J.S.R.R.D.A. 3rd Floor, F.F.P. Building, H.E.C. Campus, Dhurwa, Ranchi, upto 13.01.2016 till 17.00 hours, either by registered post or by hand, failing which the bids will be declared non-responsive.
