The Government of Jharkhand has received financing from the World Bank toward the cost of the Jharkhand Municipal Development Project and intends to apply part of the proceeds for consulting services. The nodal department for this project is Urban Development & Housing department, Jharkhand.

The consulting services ("the Services") include providing support to the Jharkhand Urban Infrastructure Development Company Ltd. (JUIDCO) to prepare an environmental and social management framework & an environment and social impact assessment for priority projects under JMDP in the State of Jharkhand achieving quality results as per standards and timely start of the project. The scope of the assignment shall include

- i. Review available documents on the economic, environment and social aspects of Jharkhand related to water supply, sewerage, drainage and SWM, ISBT, lakes especially from an environmental and social perspective.
- ii. Conduct initial consultations with all the stakeholders both at state and city level.
- iii. Review the proposed activities/sectors of investment in the context of the operational policies of the Bank and GoJ and identify the requirements for its compliance.
- iv. Develop detailed list of Environmental and Social Issues to be analyzed in the context of the proposed project with regard to impacts of proposed infrastructure and other developments.
- v. Identify investments/activities that could pose higher environmental risks.

Based on the findings above, the Consultant Firm should prepare an ESMF & ESIA outline.

The JUIDCO now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are: (i) profile of the company, (ii) annual turnover of the company for consultancy services in the last five financial years, (iii) similar assignments in preparation of an ESMF & ESIA outline carried out by the company in the last ten years, and (iv) qualified and experienced staff available with the company.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers, January 2011 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest. Consultants may associate with other firms in the form of a joint venture or a sub consultancy to enhance their qualifications.

A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
