Notice Inviting Tender

“Invitation of bids for grant of *“Mining lease”*”

In exercise of the powers conferred by Section [10B / 11] of the Mines and Minerals (Development and Regulation) Act, 1957 and in accordance with the Mineral (Auction) Rules, 2015 notified thereunder, the Government of Jharkhand has identified mineral block for the purpose of grant of **Mining lease** for the **Gold & Associated Minerals** in **Parasi, Block Tamar, District Ranchi – Jharkhand**, through electronic auction and hereby invites bids in digital format only from eligible bidders.

Those interested and eligible for bidding can participate in the bidding only after online purchase of the Tender Document on payment of the tender fee of **INR 4,94,500/-** (Indian Rupees Four Lakhs Ninety Four Thousand Five Hundred only) which is inclusive of Service Tax @ 14% , Swachh Bharat Cess @ 0.5% & Krishi Kalyan cess @ 0.5% from the website of e-auction platform provider. After purchase of the Tender Document eligible bidders can register themselves on the above mentioned website.
